FIRE

IN CASE OF FIRE:

DIAL 0 ON ANY IN-HOUSE PHONE OR (LIFT RECEIVER ON EMERGENCY PHONE)

- 1.TELL THE SWITCHBOARD OPERATOR: YOUR NAME THE EXACT LOCATION OF THE FIRE IF ANYONE IS INJURED
- 2.CLOSE ALL WINDOWS & DOORS IN YOUR IMMEDIATE WORK AREA
- **3.GRAB ONLY NECESSARY PERSONAL ITEMS**
- 4.PULL THE NEAREST FIRE ALARM PULL STATION
- 5.EVACUATE THE BUILDING VIA THE NEAREST EXIT (GO TO THE SAFE ZONE FOR YOUR BUILDING)

<u>DO NOT REENTER THE BUILDING FOR ANY REASON</u>
UNTIL YOU ARE INSTRUCTED BY THE PROPER AUTHORITY



WEAPONS ON CAMPUS

IF YOU SEE SOMEONE WITH A WEAPON ON CAMPUS OR YOU ARE TOLD SOMEONE HAS A WEAPON:

DIAL 0 ON ANY IN-HOUSE PHONE OR (LIFT RECEIVER ON EMERGENCY PHONE)

- 1. GIVE THE SWITCHBOARD OPERATOR:
 - -YOUR NAME
 - -THE EXACT LOCATION OF THE PERSON WITH THE WEAPON OR WHERE THEY WERE LAST SEEN
 - -THE NAME OF THE PERSON SUSPECTED TO HAVE THE WEAPON (IF KNOWN)
 - -A BRIEF DESCRIPTION OF THE PERSON SUCH AS: (CLOTHING, RACE, SEX, ETC.)
 - -THE WEAPON TYPE: (SHOTGUN / RIFLE / PISTOL / HANDGUN / KNIFE, ETC.)

UNDER NO CIRCUMSTANCES DO YOU APPROACH THE PERSON AND INQUIRE ABOUT THE WEAPON!

WEAPONS ON CAMPUS

HOSTAGE SITUATION

DIAL O ON ANY IN-HOUSE PHONE OR (LIFT RECEIVER ON EMERGENCY PHONE)

- 1. TELL THE SWITCHBOARD OPERATOR:
 - **-YOUR NAME**
 - -THE EXACT LOCATION OF THE HOSTAGE TAKER
 - -HOW MANY HOSTAGES HAS HE/SHE TAKEN
 - -WHAT THE HOSTAGE TAKER LOOKS LIKE:

CLOTHING, RACE, SEX, PHYSICAL CHARACTERISTICS SUCH AS (HAIR COLOR & LENGTH / COMPLEXION / HEIGHT / WEIGHT / BUILD / APPROXIMATE AGE

-WHAT TYPES OF WEAPONS YOU HAVE SEEN: (SHOTGUN / RIFLE / HANDGUN / PISTOL / KNIFE)

- -IF ANYONE HAS BEEN INJURED
- 2. ALERT OTHERS IN YOUR IMMEDIATE WORK AREA OF THE SITUATION
- 3. GRAB ONLY NECESSARY PERSONAL ITEMS AND EVACUATE VIA THE NEAREST EXIT
- 4. GO TO THE SAFE ZONE FOR YOUR PARTICULAR BUILDING

IF YOU CAN'T EVACUATE SAFELY, CLOSE THE DOOR AND STAY IN YOUR WORK AREA UNTIL YOU HEAR THE PROPER AUTHORITY EXCLAIM, "CODE 10-39 HAS BEEN LIFTED."

IF YOU ARE THE HOSTAGE, COOPERATE WITH THE HOSTAGE TAKER UNTIL THE SITUATION HAS BEEN DISPENSED WITH.

HOSTAGE SITUATION

CHEMICAL SPILL

IF A CHEMICAL IS SPILLED IN YOUR WORK AREA THAT COULD POSE A HEALTH RISK TO OTHERS:

- 1. EVACUATE THE AREA AND <u>DIAL 0</u> ON ANY IN-HOUSE PHONE OR (LIFT RECEIVER ON EMERGENCY PHONE)
- 2. TELL THE SWITCHBOARD OPERATOR:
- YOUR NAME
- -THE EXACT LOCATION OF THE SPILL (BUILDING / ROOM NUMBER)
- - WHAT TYPE OF CHEMICAL WAS SPILLED
- - IF ANYONE HAS BEEN INJURED
- 3. ALERT OTHERS IN YOUR IMMEDIATE WORK AREA OF THE SITUATION
- 4. KEEP A SAFE DISTANCE AND ATTEMPT TO SECURE THE AREA
- 5. CLOSE DOORS / WINDOWS AND DO NOT ALLOW ANYONE TO ENTER UNTIL THE SPILL HAS BEEN REMOVED OR THE AREA HAS BEEN DECLARED SAFE

CHEMICAL SPILLS

MEDICAL EMERGENCIES

IN CASE OF A MEDICAL EMERGENCY:

DIAL 0 ON ANY IN-HOUSE PHONE OR (LIFT RECEIVER ON EMERGENCY PHONE)

DIAL 9-911 FIRST IF THE SITUATION APPEARS LIFE THREATENING!

- 1. TELL THE SWITCHBOARD OPERATOR:
 - -YOUR NAME
 - -THE EXACT LOCATION OF THE INDIVIDUAL NEEDING ASSISTANCE
 - -WHAT SYMPTOMS THE INDIVIDUAL IS DISPLAYING OR WHAT INJURIES THE INDIVIDUAL HAS SUSTAINED
 - -IF YOU NEED RESCUE

FIRST AID STATIONS ARE LOCATED IN EACH BUILDING. EACH KIT IS EQUIPPED WITH A BLOOD PRESSURE CUFF AND STETHOSCOPE.

REPORTING CRIMES / SAFETY ISSUES

THE FOLLOWING SHOULD ALWAYS BE REPORTED TO THE CAMPUS POLICE (VIA ONE OF THE ABOVE METHODS):

-IF YOU ARE THE VICTIM OF A CRIME: YOU ARE THE VICTIM OF A CRIME IF:

- 1. YOU HAVE SOMETHING STOLEN FROM YOU PERSONALLY OR IF SCHOOL PROPERTY IS MISSING FROM YOUR WORK AREA. REMEMBER, YOU SHOULD CONSIDER IT STOLEN IF YOU HAVE MADE AN EXTENSIVE SEARCH AND CAN'T LOCATE THE ITEM. REMEMBER, THE VALUE OR LACK OF VALUE OF AN ITEM SHOULD NOT BE A FACTOR IN DECIDING WHETHER IT SHOULD BE REPORTED.
- 2. YOU ARE THREATENED / VERBALLY ABUSED
- 3. YOU ARE ASSAULTED
- 4. YOU ARE INVOLVED IN A HIT & RUN

-IF YOU WITNESS OR HAVE KNOWLEDGE OF THE FOLLOWING:

- 1. THEFT
- 2. VANDALISM
- 3. THREATS / ARGUMENTS / VERBAL ABUSE
- 4. ASSAULTS
- 5. DRUGS
- 6. TRAFFIC ACCIDENTS / TRAFFIC VIOLATIONS / SPEEDING

OR

-IF YOU HAVE KNOWLEDGE OF OSHA COMPLIANCE ISSUES OR SAFETY ISSUES INVOLVING THE FOLLOWING:

- 1. MATERIAL SAFETY DATA SHEETS
- 2. ELECTRICAL HAZARDS
- 3. MACHINE GUARDS MISSING
- 4. INFECTIOUS DISEASE CONTROL
- 5. PERSONAL PROTECTIVE EQUIPMENT

REPORTING CRIMES/SAFETY ISSUES

Suspicious Mail / Foreign Substances

IF YOU RECEIVE SUSPICIOUS MAIL:

DIAL 0 ON ANY IN-HOUSE PHONE OR (LIFT RECEIVER ON EMERGENCY PHONE)

- 1. TELL THE SWITCHBOARD OPERATOR:
 - -YOUR NAME
 - -THE EXACT LOCATION OF THE SUSPICIOUS MAIL/FOREIGN -SUBSTANCE
 - -IF YOU OR SOMEONE ELSE HAS BEEN EXPOSED
 - -IF MEDICAL ATTENTION IS NEEDED
- 2. CLOSE ALL WINDOWS AND DOORS IN YOUR IMMEDIATE WORK AREA
- 3. ALERT OTHERS IN YOUR IMMEDIATE WORK AREA OF THE SITUATION
- 4. KEEP A SAFE DISTANCE AND ATTEMPT TO SECURE THE AREA
- 5. DO NOT HANDLE/TOUCH THE SUSPICIOUS MAIL/FOREIGN
 SUBSTANCE. PULL THE NEAREST FIRE ALARM PULL STATION AND EVACUATE
 THE BUILDING VIA THE NEAREST EXIT
 (GO TO THE SAFE ZONE FOR YOUR BUILDING)

MAIL SHOULD BE CONSIDERED SUSPICIOUS IF:

- NO RETURN ADDRESS/RESTRICTIVE MARKINGS (EX. "PERSONAL")
- POSSIBLY MAILED FROM A FOREIGN COUNTRY
- MISSPELLED WORDS
- ADDRESSED TO TITLE ONLY OR INCORRECT TITLE (EX. "CHAIRMAN"
 "DEAN" "PROFESSOR" ETC.)
- BADLY TYPED/WRITTEN
- PROTRUDING WIRES
- LOPSIDED OR UNEVEN
- RIGID OR BULKY
- STRANGE ODOR
- OILY STAINS/DISCOLORATIONS/OR CRYSTALIZATION ON WRAPPER
- EXCESSIVE TAPE OR STRING

A SUBSTANCE SHOULD BE CONSIDERED FOREIGN IF:

- IT APPEARS POWDERY OR CRYSTALLINE AND IT IS FOUND IN A LOCATION OR ON A SURFACE ON CAMPUS WHERE IT WOULD NOT NORMALLY BE SEEN/UTILIZED
- IT IS WHITE/OFF WHITE/VANILLA OR PASTEL IN COLOR

WEATHER EMERGENCIES & INCLEMENT WEATHER

IN CASE OF IMPENDING THREATENING WEATHER:

- 1. WHILE YOU ARE AT WORK:
 - LISTEN FOR BROADCASTS OVER THE COLLEGE INTERCOM SYSTEM. DECISIONS WILL BE MADE IN A TIMELY MANNER TO CLOSE THE COLLEGE. DEPARTMENT CHAIRS WILL BE CONTACTED BY PHONE OR IN PERSON WITH SPECIFIC INSTRUCTIONS. THE CHAIRS WILL BE RESPONSIBLE FOR NOTIFYING THEIR STAFF.
- 2. IF THREATENING WEATHER IS ABOUT TO EFFECT THE CAMPUS WITH LIMITED ADVANCE WARNING:
 - CLOSE ALL WINDOWS AND DOORS IN YOUR IMMEDIATE WORK AREA. GO TO AN INNER HALLWAY OR ROOM AS CLOSE TO THE CENTER OF YOUR BUILDING AS POSSIBLE.
 - SIT ON THE FLOOR AND WAIT FOR FURTHER INSTRUCTIONS. DO NOT ATTEMPT TO GO BACK TO YOUR WORK AREA OR LEAVE THE CAMPUS.

BUILDING 1 & 5 OCCUPANTS SHOULD GO THE THE BOTTOM FLOOR OF THEIR BUILDING AND FOLLOW THE ABOVE PROCEDURE.

BUILDING 6, 7, 8A AND 10B OCCUPANTS SHOULD EVACUATE (IF POSSIBLE) TO THE NEAREST SOUND (BRICK) CAMPUS BUILDING AND FOLLOW THE ABOVE PROCEDURE.

- 3. IF YOU ARE AT HOME AND HAZARDOUS WEATHER CONDITIONS HAVE BEEN FORECAST:
 - YOUR DEPARMENT CHAIR OR SUPERVISOR WILL CONTACT YOU BY PHONE AND ADVISE YOU ABOUT YOUR WORK SCHEDULE.

IN CASE OF A BOMB THREAT:

- 1. DON'T HANG UP
 KEEP THE CALLER ON THE LINE
- 2. BEGIN TO COMPLETE THE BOMB THREAT QUESTIONNAIRE (NEXT PAGE)

(WRITE YOUR RESPONSES ON A SEPARATE SHEET OF PAPER IF POSSIBLE)

AFTER THE CALLER HANGS UP:

1. DIAL 0 ON ANY IN-HOUSE PHONE:

TELL THE SWITCHBOARD OPERATOR YOUR NAME

THEN SAY, "I HAVE JUST RECEIVED A BOMB THREAT"

(THE SWITCHBOARD OPERATOR WILL KNOW WHAT EXTENSION YOU ARE CALLING FROM IF YOU ARE ON AN IN-HOUSE PHONE)

IF YOU ARE CALLING FROM A PAY PHONE OR ONE OF THE BUILDING EMERGENCY PHONES YOU WILL NEED TO TELL THE SWITCHBOARD OPERATOR:

"I'M ON THE EMERGENCY PHONE IN BUILDING (GIVE BUILDING NO.")

OR

"I'M AT THE PAY PHONE IN BUILDING (GIVE BUILDING NO.")

(TELL THE SWITCHBOARD OPERATOR WHAT EXTENSION OR TELEPHONE NUMBER THE CALL CAME IN ON IF YOU USE A DIFFERENT PHONE TO REPORT THE INCIDENT.)

(TELL THE SWITCHBOARD OPERATOR WHAT TIME YOU RECEIVED THE CALL AND APPROXIMATELY HOW LONG THE CALLER REMAINED ON THE LINE.)

- 2.CLOSE ALL WINDOWS AND DOORS IN YOUR IMMEDIATE WORK AREA
- 3. GRAB ONLY NECESSARY PERSONAL ITEMS
- 4. EVACUATE THE BUILDING VIA THE NEAREST EXIT
- 5.CARRY THE BOMB THREAT QUESTIONNAIRE RESPONSES TO THE SWITCHBOARD ASAP!
- 6.GO TO THE DESIGNATED SAFE ZONE FOR YOUR BUILDING AND WAIT

DO NOT REENTER THE BUILDING FOR ANY REASON UNTIL YOU ARE INSTRUCTED BY THE PROPER AUTHORITY.
